 ${\bf R} \ {\bf v} \ {\bf D}$ - Youth, charged with s18 Wounding with intent. Convicted of s20 Wounding

R v H - Stalking. Acquitted



Criminal Prosecution

R v A - Attempted Murder. Convicted s18 OAPA

R v D & others - Conspiracy to Murder. Convicted

R v B & others - 5-handed Conspiracy to Supply Class A drugs. All convicted

R v N - Arson with Intent. Defence of Insanity raised. Convicted

R v W - Multiple allegations of Sexual Activity with a child. Convicted

R v O - Bomb Hoax. PII applications. Acquitted

R v A - Child Cruelty. Complainant hostile. Acquitted

Fraud & Financial Crime

R v F – Prosecuted significant benefit fraud where defendant did not agree any evidence. Convicted_

R v J – Defended a client who had recently arrived in the UK and had claimed a range of benefits. Acquitted of some offences

R v K - Prosecuted a defendant accused of fraudulently applying for a large number of loans. Convicted

 $\mathbf{R}~\mathbf{v}~\mathbf{W}$ – Prosecuted complex fraud spanning years involving selling funeral plans. Convicted

 ${\bf R} {\bf \, v} {\bf \, P}$ – Defended a client accused of fraudulently obtaining substantial sums from her mother. Acquitted
